

TERMS OF PAYMENT: TERMS OF SALE ARE NET 30 DAYS NO DISCOUNT ALLOWED. A SERVICE CHARGE OF 1.5% PER MONTH/ 18% PER ANNUAL/ WILL BE APPLIED TO ALL INVOICES 30 DAYS PAST DUE. ANY ACCOUNT, HAVING A BALANCE DUE THAT IS 60 DAYS OLD, MAY BE PLACED ON A CREDIT HOLD CONDITION. FREIGHT ALLOWANCE: ALL UNITS ARE PRICED FOB FACTORY. NO FREIGHT ALLOWED. DROP SHIPMENTS: THE COMPANY RESERVES THE RIGHT TO REFUSE TO MAKE DIRECT SHIPMENTS TO POINTS OF DESTINATION OUTSIDE OF THE REGULAR OR ASSIGNED SALES AND SERVICE AREA OF THE DISTRIBUTOR. PRICES: PRICES ARE SUBJECT TO CHANGE WITHOUT NOTICE. IN THE EVENT OF PRICE INCREASES, ALL ORDERS ON HAND WILL BE FILLED AT LOWER PRICES PROVIDED SUCH ORDERS ARE RELEASED FOR SHIPPING WITHIN 60-DAYS AFTER PRICE INCREASE. IF THE ORDERS CANNOT BE RELEASED FOR SHIPMENT WITHIN THE 60-DAY GRACE PERIOD, THE ORDERS WILL BE BILLED AT PRICES IN EFFECT AT TIME OF SHIPMENT. SPECIAL QUOTED ORDERS WHICH CANNOT BE RELEASED FOR SHIPMENT WITHIN THE 60 DAY GRACE PERIOD WILL BE SUBJECT TO AN INCREASE IN PRICE BASED ON THE SAME PERCENTAGE INCREASE AS OTHER ITEMS IN OUR LINE ARE INCREASED. ALL ORDERS ARE SUBJECT TO ACCEPTANCE AT THE CONCEALITE OFFICE AND CONTINGENT UPON FIRES, STRIKES, MACHINERY BREAKDOWN, OR ANY CAUSES BEYOND OUR CONTROL. ANY TAXATION LEVIED UPON SALE, PRODUCTION OR TRANSPORTATION OF THOSE GOODS IS TO BE BORNE BY PURCHASER. POSSESSION OF THIS LIST DOES NOT NECESSARILY CONSTITUTE AN OFFER TO SALE. HOLD ORDERS: WE CANNOT ORDER ANY SPECIAL COMPONENTS OR SCHEDULE SPECIFIC JOB PRODUCTION UNTIL A FIRM RELEASE IS GIVEN. CANCELLATIONS: ALL ORDERS CANCELED AFTER BEING PROCESSED; PRIOR TO SHIPMENT WILL BE SUBJECT TO CANCELLATION CHARGES. ORDERS ARE NOT SUBJECT TO CANCELLATION EXCEPT ON PAYMENT FOR WORK PERFORMED, INCLUDING ENGINEERING CHARGES ON CUSTOM MATERIAL. ALL COST, FOR WAREHOUSING AND FREIGHT ON ORDERS CANCELED AFTER SHIPMENT AND/OR REFUSED AT DESTINATION WILL BE CHARGED TO CUSTOMER. TRANSPORTATION CLAIMS: ALL FIXTURES ARE INSPECTED PRIOR TO SHIPPING. TRANSPORTATION AUTHORITIES REGULARLY INSPECT OUR PACKAGING AND ASSUME RESPONSIBILITY FOR OUTER AND CONCEALED DAMAGE WHICH OCCURS IN SHIPMENT. OUR RESPONSIBILITY FOR SAFE DELIVERY CEASES WHEN MERCHANDISE HAS BEEN TURNED OVER TO THE CARRIER IN GOOD CONDITION. SHIPMENT SHOULD BE THOROUGHLY CHECKED UPON RECEIPT FOR DAMAGE OR SHORTAGE IN TRANSIT AND, IF DAMAGE OR SHORTAGE OCCURS CLAIM SHOULD BE FILED AT ONCE WITH THE DELIVERING CARRIER BY PURCHASER. WE WILL BE GLAD TO ASSIST WHEN CALLED UPON. ALL DAMAGES CLAIMS MUST BE MADE WITHIN 30 DAYS.
